**Objection to LDP proposal - references H-BU11 & H-BU12 at Broxburn.**

Dear Fiona,

On behalf of Broxburn United Sports Club Trust (BUSC) I am writing to lodge our objection to the LDP proposal regarding the 2 references noted. Our objection is regarding the reduction in essential car parking for our members and visitors at both these location but in particular H-BU11.

Our Albyn Park facility has over 700 members consisting of 32 teams and equivalent visiting teams. We have a weekly through flow of around 3000 people to Albyn Park over a 7 day operation.

Parking is a big issue in this area due to ourselves and West Lothian Leisure (Xcite). Residents in Church St have complained for many years to Keir Stevenson at WLC about parking issues caused by Xcite and ourselves. BUSC only have 25 parking spaces at Albyn park with another additional 18 provided at Buchan Park BC.

We desperately require to retain these H-BU11 Stewartfield parking spaces where we manage 5 playing fields in addition to our artificial pitch at Albyn Park. Parents also use the road parking at H-BU12 to access Stewartfield parks from the east end.
