

PRIVACY NOTICE – Housing, Customer & Building Service – Factoring

This notice explains what information the council needs in order to process Factoring Charges and Services to its customers as indicated in the Property Factors (Scotland) Act 2011.

YOUR PERSONAL INFORMATION AND HOW IT WILL BE USED

Under data protection law, the lawful bases we rely on for processing this information are:

- a) Your consent. You are able to remove your consent at any time. You can do this by contacting us, <u>please click this link to see the contact</u> details section on this form
- b) We have a contractual obligation We need to collect your personal information so that we can provide you with the factoring service.
- c) We have a legal obligation In order to properly operate as a factor and to ensure homeowners meet their requirements, the Council has to process personal information about an owner. This will be done in accordance with the Data Protection Act 1998 and in line with the Council's policies and procedures.

Most of the personal information we process is provided to us directly. We also receive personal information indirectly.

YOUR RIGHTS

Under data protection law, you have rights including:

You have the right to ask us for copies of your personal information. Your right of access

You have the right to ask us to rectify personal information you think is inaccurate. You also have Your right to rectification

the right to ask us to complete information you think is incomplete.

You have the right to ask us to erase your personal information in certain circumstances. Your right to erasure



Your right to restriction of processing	You have the right to ask us to restrict the processing of your personal information in certain circumstances.
Your right to object to processing	You have the the right to object to the processing of your personal information in certain circumstances
Your right to data portability	You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
