

# PRIVACY NOTICE - Housing, Customer & Building Services - Landlord Registration

This notice explains what information the council needs in order to process requests for advice and assistance regarding Private Landlord Registration.

As indicated in the Antisocial Behaviour (Scotland) Act 2004, Local Authorities have a duty to provide private landlords and tenants with advice and assistance relating to such tenancies.

#### YOUR PERSONAL INFORMATION AND HOW IT WILL BE USED

Under data protection law, the lawful bases we rely on for processing this information are:

- a) Your consent. You are able to remove your consent at any time. You can do this by contacting us, <u>please click this link to see the contact</u> details section on this form
- b) We have a legal obligation we have to comply with a legal obligation under The Anti-Social Behaviour etc (Scotland) Act 2004 for a person to be registered if they are the owner of residential property which is subject to a lease or occupancy agreement and is not specifically excluded.

Most of the personal information we process is provided to us directly. We also receive personal information indirectly.

## **YOUR RIGHTS**

Under data protection law, you have rights including:

Your right of access You have the right to ask us for copies of your personal information.

You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.



Your right to erasure	You have the right to ask us to erase your personal information in certain circumstances.
Your right to restriction of processing	You have the right to ask us to restrict the processing of your personal information in certain circumstances.
Your right to object to processing	You have the the right to object to the processing of your personal information in certain circumstances
Your right to data portability	You have the right to ask that we transfer the personal information you gave us to another

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
