TITLE OF PREVIOUS SPG / DATE ADOPTED	REASONING FOR NOT REPLACING
Development Control Guidance : Pigeon lofts - 2003	Proposals of this nature are now rare and do not warrant the need for bespoke guidance. Any amenity considerations which are raised can be dealt with by other policies in the Local Development Plan and can be satisfactorily controlled through conditions of a planning permission.
A Development Control policy for the control of amateur radio antenna and satellite dish receivers - 1998	Technological change has made many such installations obsolete and the liberalisation of 'permitted development' rights has removed many such developments from planning controls.
Delivering the next round of major housing developments in West Lothian - 2003	This guidance related to the initial designation of Core Development Areas (CDAs) and was of its time. It has served its purpose and is no longer of relevance.
Materials on roads - 2003	This guidance was introduced to address a particular issue at the time it was written. Since then planning conditions have been introduced to help address the problem together with more proactive enforcement.
A policy on the control of changes of use to offices in Linlithgow High Street - 1984	The new Local Development Plan does not include policies which restrict a change of use of this nature thereby rendering supplementary guidance unnecessary and redundant.
