1. Introduction

This statement sets out West Lothian Council's determination in accordance with Section 10(1) of the Environmental Assessment (Scotland) Act 2005 on whether or not a Strategic Environmental Assessment (SEA) is required for Planning Guidance (PG) – Mobile Snack Bars.

Screening is the first stage in the SEA process. The purpose of screening is to establish whether or not a Plan, Programme or Strategies (PPS), will have significant environmental effects. Screening takes the form of a formal submission, where the responsible authority (the Council), seeks the views of the following Consultation Authorities on whether a PPS is likely to have significant environmental effects and therefore whether a SEA is required:

- ◆ Historic Environment Scotland (HES)
- ◆ Scottish Environmental Protection Agency (SEPA), and
- ◆ Scottish Natural Heritage (SNH)

As well as consulting the above bodies, responsible authorities are required to take into account the criteria set out in Schedule 2 of the 2005 Act when determining whether or not the plan is likely to have significant effects. The details of this process are contained within the Screening Report.

If the responsible authority and the consultation authorities agree that the plan or programme is unlikely to have significant environmental effects, the responsible authority is required to make a determination to that effect under section 8(1) of the 2005 Act.

In accordance with section 9(1) of the 2005 Act, West Lothian Council submitted to the Consultation Authorities a screening report summarising its views as to whether West Lothian Local Development Plan Planning Guidance (PG) – Mobile Snack Bars will have significant environmental effects.

In formally determining under Section 8(1) of the Act whether a SEA is required, the Council has taken into account the views of the three Consultation Authorities; Scottish Environment Protection Agency, Scottish Natural Heritage and Historic Environment Scotland which were issued through the SEA Gateway on 28 April 2020.

West Lothian Council and the Consultation Authorities are in agreement that the West Lothian Local Development Plan Planning Guidance (PG) – Mobile Snack Bars is not likely to have significant environmental effects and the Council has therefore determined that an SEA **will not be required** for the plan under Regulation 13(1) of the 2005 Act.

The guidance will support consistent interpretation and application of policies through the development management process. The guidance will illustrate good practice in-line with the policy and other similar Scottish local planning authority guidance. The potential environmental effects of any proposed development considered under the terms of the policies can only be properly assessed at the planning application stage when the specific site details are known.</p> <p>In particular, this PG further defines the terms used in the policies and explains and interprets other matters necessary for the implementation of the policy and provides general planning criteria applicable to all sites.</p>
<p>What promoted the PPS: (e.g. a legislative, regulatory or administrative provision)</p>	<p>The current Supplementary Planning Guidance (SPG) was adopted in 1998 in support of the Bathgate Area Local Plan (1998) and subsequent West Lothian Local plan (2009). While continuing to provide valid and pertinent guidance it does nevertheless pre-date the now adopted West Lothian Local Development Plan (September 2018). As a consequence there is recognition of the need to ensure that the council's planning guidance is up to date and reflective of the most current policies and practices.</p> <p>West Lothian Council adopted the West Lothian Local Development Plan on 4 September 2018 after Scottish Ministers confirmed the council could do so. It now forms part of the Development Plan for West Lothian along with</p>

Summary of Environmental Effects

The Council has considered the likely significance of effects on the environment of Planning Guidance (PG) – Mobile Snack Bars and these are set out below.

Table 2: Summary of Environmental Effects

The council has prepared this Planning Guidance to proactively inform and encourage developers to adopt a more considered approach when preparing proposals for new mobile snack bars.

The guidance has been conceived to help positively influence the nature of new mobile snack bars and to mitigate any adverse effects on both the site and the surrounding environment. It relates to both development in the countryside and development within and on the periphery of settlements, as well as within industrial estates.

Developers are initially challenged to justify the need for such facilities, but when a case can be sustained they are encouraged to identify and address in particular the consequences with particular regard to the location and to adopt ‘best practice’.

With careful thought and sensitive execution, particularly in terms of their location, mobile snack bars can be made to be in much better harmony with their neighbours and the wider natural environment.

In common with other guidance prepared by West Lothian Council, it has been subject to internal and external consultation, in this case with council service providers and community councils, planning consultants and developers and regard has been had to the responses and feedback which has been received and present to elected members to consider.

The guidance sets out detailed criteria to assist the development and assessment of proposals for development across the plan area and specifically supports policies: TRAN 4: Advertisements within Key Transport Corridors; ENV 1: Character and Special Landscape Areas; and ENV 3: Other Development in the Countryside, as well as TCR 3 (Commercial Entertainment and food premises) of the adopted LDP which collectively seek to prevent and minimize visually and environmentally intrusive development and to reduce energy use and carbon emissions.

The West Lothian Local Development Plan has itself already undergone an extensive SEA examining its policies, proposals and land use allocations. They demonstrate West Lothian Council's commitment to environmentally sensitive development and the addition of Planning Guidance (PG) – Mobile Snack Bars and is considered to strengthen and re-inforce this position.

Development always has the potential to have adverse environmental consequences but additional care needs to be exercised in relation to sites of a particularly sensitive environmental nature. The specific policies referenced in the guidance will not however be applied in isolation; There are other policies included in the Local Development Plan which will additionally be applied in the assessment of proposals for mobile snack bars.

The council considers it unlikely that the supporting Planning Guidance (PG) – Mobile Snack Bars will have any significant environmental effects as it will provide only information for decision makers, the public and other stakeholders on particular mobile snack bar proposals

Overall, it is considered that the Planning Guidance (PG) – Mobile Snack Bars is a qualifying plan or programme that will not have significant environmental effects and that, as part of a wider policy framework, significant environmental effects arising from new development permitted under the terms of the adopted Local Development Plan and associated guidance will be avoided.

In conclusion, the Planning Guidance on Mobile Snack Bars will result in no, or minimal, environmental effects and therefore it is concluded a SEA is NOT required.

However, should a particular instance arise where adherence to the PG was considered to be potentially detrimental to the environment, the Development Management process would be expected to have regard to such matters and to apply appropriate and proportionate mitigation measures through planning conditions on any planning permissions for mobile snack bars released by the council.

Thank you for your Screening Report consultation which SEPA received via the Scottish Government SEA Gateway on 31 March 2020.

In accordance with Section 9(3) of the Environmental Assessment (Scotland) Act 2005 we have considered your screening report using the criteria set out in Schedule 2 for determining the likely significance of effects on the environment. Having reviewed the Screening Report, we consider that in respect of our main areas of interest (air, water, soil, human health, material assets (of which we have a specific interest in waste) and climatic factors) the Planning Guidance Mobile Snack Bars is unlikely to have significant environmental effects. Although we are of the view that significant environmental effects are not likely, it is for the West Lothian Council as Responsible Authority to make a formal determination taking into account the consultation responses received.

If it is formally determined that SEA is required, you will be aware that the next stage requires the Responsible Authority to consult the Consultation Authorities on the proposed scope and level of detail to be included within the Environmental Report. This can be undertaken through preparation of a concise Scoping Report. We would encourage you to use the scoping process to focus the assessment on those SEA issues upon which there are likely to be significant environmental effects, to outline the baseline information you consider as most relevant and explain your proposed method of assessment.
