The personal information we collect

We will collect personal information about you. This information can include, but will be the minimum to process your request or our statutory requirement:

• your name, address, telephone number, email address, a copy of your disabled badge, a copy of your vehicle V5 form, contractor details.

How we get your personal information and why we have it.

Most of the personal information we process is provided to us directly by you for one of the following reasons:

 You have asked us to provide you with a service/information and we need your personal information to be able to provide that to you. Service may include:

Disabled parking bay request, dropped kerb application, flood risk alert system, road permit.

 We have asked you to complete a survey and may contact you in association with the survey you have completed.

We also receive personal information indirectly, from the following sources in the following scenarios: Not applicable.

Under data protection law, the lawful bases we rely on for processing this information are:

We have consent

We need it to perform a public task.

Who we will share your information with?

• We will only share this information with West Lothian Council colleagues to compile a response to your enquiry or to carry out the work requested.

Only the minimum amount of information required will be shared.

Your information will not be shared with the public.

How long do we keep your information?

- General enquiries, surveys we will keep your information for a period of six years after resolution of your enquiry to help us with reporting and planning in the future.
- Disabled parking applications We will keep your information until such a time
 as the bay applied for is no longer required. In the case of unsuccessful
 applications data is retained for a period of 18 months to accommodate appeals.
 (Consideration is currently being given to limit the timeframes for appeals to 3
 months and data retention to 9 months.)
- **Dropped Kerb Application** We will keep your information for a period of two years from when your application is approved.
- Flood Prevention Alert Scheme for the duration of you being on the scheme.
- Permit
 - S56 and S109, we will keep your information for a period of six years following completion of the work.
 - For scaffolding and skip permits, we will keep your information for a period of one year after your application is approved.

• **Surveys** - We will keep your information for a period of **five years** after you complete the survey, although personal data captured is minimal.

Your rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
