## Glossary of terms

<b>Affordable housing</b>	Housing of a reasonable quality that is affordable to people on modest incomes. In some places the market provides some or all of the affordable housing needed, while in other places it will be necessary to make housing available at a cost below market value to meet an identified need.
<b>Air Quality Management Area (AQMA)</b>	An area declared by a local authority where national air quality standards are not being met, or in danger of not being met.
<b>Allocation</b>	Land identified in a local plan/local development plan as appropriate for a specific land use.
<b>Battlefield sites</b>	Sites within Historic Scotland's Inventory of Historic Battlefields, a list of nationally important battlefields in Scotland.
<b>Brownfield site</b>	Land which has previously been developed. The term may encompass vacant or derelict land; infill sites; land occupied by redundant or unused buildings; and developed land within the settlement boundary where further intensification of use is considered acceptable. A brownfield site should not be presumed to be suitable for development.
<b>Central Scotland Green Network (CSGN)</b>	National-scale project identified by Scottish Government through <i>National Planning Framework</i> defined as 'A strategic network of woodland and other habitats, active travel routes, greenspace links, watercourses and waterways, providing an enhanced setting for development and other land uses and improved opportunities for outdoor recreation and cultural activity'. See Green Corridors and Green Network.
<b>Climate change</b>	A change in the "average weather" that a given region experiences.
<b>Commercial leisure development</b>	Developments that attract large numbers of people including multiplex cinemas, bingo halls, nightclubs, tenpin bowling, casinos, and commercial sports facilities, including health and fitness centres.
<b>Comparison retail</b>	Shopping not classified as Convenience retail. The purchaser will compare items on the basis of price and quality before a purchase is made. Comparison retail items are not purchased on a regular basis, unlike convenience retail items. Comparison retail can be further categorised as Personal retail and Household (bulky goods) retail.
<b>Conservation areas</b>	An area designated under the Town and Country Planning (Scotland) Act 1997 as being of particular architectural or historic value within which greater planning controls are exercised in order to protect the character of the area.
<b>Constrained housing land supply</b>	That part of the established housing land supply which may be affected by infrastructure constraints, land contamination or ownership/marketing issues.
<b>Convenience shopping</b>	Broadly defined as food shopping, drinks, tobacco, newspapers, magazines and confectionary, purchased regularly for immediate consumption.
<b>Core Paths Network</b>	Core Paths are a new feature of the outdoor access provisions brought in by the Land Reform (Scotland) Act 2003. As a system they can comprise many different types of path and will cater for all types of user. They will satisfy the basic path needs for local people and visitors, providing links to the wider path network and countryside.
<b>Cumulative impact (retail)</b>	Combined effect of all out-of-centre developments, developed and proposed, on the town centre, or the effect of such developments on all strategic centres, including the town centre.
<b>Density</b>	The intensity of development in a given area. It is usually measured as a net dwelling density, e.g. 30 dwellings to the hectare.
<b>Derelict land</b>	Land which has been so badly damaged by development or use that it is incapable of being developed for beneficial use without rehabilitation.
<b>Design and Access Statement</b>	Required to be submitted with certain planning applications (e.g. for national or major developments, or within conservation areas), outlining the design principles guiding the application, and how design issues impacting on disabled people have been addressed



<b>Developer Contribution</b>
Financial (or in kind) contribution towards infrastructure required as a result of development.
<b>Edge of centre</b>
A location within easy walking distance of the town centre, and usually adjacent to the town centre, and providing parking facilities that serve the centre as well as the store, thus enabling one trip to serve several purposes.
<b>Effective housing land supply</b>
That part of the established housing land supply which is free or is expected to be free of development constraints in the period under consideration, and will therefore be available for the construction of housing.
<b>Edinburgh Glasgow Improvement Project (EGIP)</b>
A set of enhancement works on the Edinburgh/Glasgow/Dunblane rail corridor aimed at increasing capacity and reducing journey times.
<b>Employment Land Supply</b>
All land and buildings used or designated for purposes under Classes 4 (Business), 5 (General Industry) and 6 (Storage and Distribution) of the 1997 Town and Country Planning (Use Classes) (Scotland) Order, considered to be appropriate or marketable as per the definition set out in SPP and by Planning and Economic Development Services.
<b>Environmental Impact Assessment (EIA)</b>
Procedure governed by the Environmental Impact Assessment (Scotland) Regulations 2011, whereby the likely environmental effects of certain types and scales of development, and developments in sensitive locations, are examined in sufficient detail before the grant of planning permission
<b>Environmental Report</b>
Documents the <i>Strategic Environmental Assessment</i> (SEA) of the LDP. A SEA of the LDP is required by the Environmental Assessment (Scotland) Act 2005
<b>Equalities Impact Assessment (EqIA)</b>
This is a thorough and systematic analysis to determine the extent of the impact of a new policy upon the equalities categories.
<b>Established housing land supply</b>
The total housing land supply - including both unconstrained and constrained sites. Includes the effective housing land supply, plus the remaining capacity of sites under construction, sites with planning consent; sites in adopted local development plans and where appropriate other buildings and land with agreed potential for housing development.

<b>Flood risk</b>
The combination of the probability of a flood and of the potential adverse consequences, associated with a flood, for human health, the environment, cultural heritage and economic activity.
<b>Flood Risk Assessment</b>
An assessment carried out to predict and assess the probability of flooding for a particular site or area and recommend feasible mitigation measures
<b>Fluvial flooding</b>
The most common source of flooding when water levels in rivers rise and overtop their banks.
<b>Forth Area River Basin Management Plan (FRBMP)</b>
A plan aimed at maintaining and improving the ecological status of the rivers, lochs, estuaries, coastal waters and groundwaters in the Forth area, prepared by SEPA and partner organisations.
<b>Functional flood plain:</b>
These store and convey flood water during times of flood. These functions are important in the wider flood management system. For planning purposes the functional flood plain will generally have a greater than 0.5% (1:200) probability of flooding in any year.
<b>Garden and Designed Landscape</b>
An area of significant parkland and woodland, generally centred upon a castle or mansion house, which has been laid out for artistic effect and identified in the "Scottish Inventory of Gardens and Designed Landscapes". May also include non-inventory sites of more local interest.
<b>Geodiversity</b>
The variety of rocks, minerals, fossils, landforms, sediments and soils, together with the natural processes which form and alter them, and the foundation on which plants, animals and humans live.
<b>Greenfield land</b>
Land in a settlement or rural area which has never been developed, or where traces of any previous development are now such that the land appears undeveloped.

<p><b>Habitats Regulations Appraisal</b></p> <p>Habitats Regulations Appraisal is the term used to describe an assessment of the implications of the policies and proposals of the <i>Local Development Plan</i> on Special Protected Areas (SPAs) or Special Areas of Conservation (SACs). This assessment is required by the European Habitats Directive 1992 as transposed in UK law by the Conservation (Natural Habitats, &amp;c.) Regulations 1994. If it is determined that there will be a significant affect on a European site, then an appropriate assessment under regulation BSB(1) is then required.</p>	<p><b>Housing Land Audit (HLA)</b></p> <p>The established means for monitoring housing land supply, which takes the form of an annual report. It has two key functions: to demonstrate the availability of sufficient effective land to meet the requirement for a continuous five-year supply; and to provide a snapshot of the amount of land available for the construction of housing at any particular time.</p>
<p><b>House(s) in Multiple Occupation</b></p> <p>A house were more than five residents live together as unrelated individuals, or a flat where three or more residents live together as unrelated individuals.</p>	<p><b>Housing Market Areas (HMAs)</b></p> <p>A geographical area which is relatively self-contained in terms of reflecting peoples' choice of location for a new home i.e. a large percentage of people settling in the area will have sought a house only in that area.</p>
<p><b>Housing demand</b></p> <p>The quantity and type/quality of housing which households wish to buy or rent and are able to afford.</p>	<p><b>Indicative Flood Map</b></p> <p>Provides a Scotland wide picture of the areas at risk of flooding from rivers and the sea. <p><b>Health Impact Assessment</b></p> <p>An assessment to predict the health consequences of a new policy or proposal and produces recommendation as to how the good consequences for health could be enhanced and how the bad consequences could be avoided or minimised</p>	<p><b>Local Development Plan (LDP)</b></p> <p>Introduced by the Scottish Government in 2008 as replacement for the Local Plans. These plans set out a detailed vision and strategy for an area. In doing so they provide detailed guidance of development including where development should, or should not take place. Local Development Plans will over time replace Local Plans and are to be reviewed every five years.</p>
	<p><b>Local Housing Strategy (LHS)</b></p> <p>Provides the strategic direction to tackle housing need and demand and to inform the future investment in housing and related services across the local authority area.</p>

<b>Local Landscape Area (LLA)</b>
West Lothian Council's local landscape designations (previously called Areas of Great Landscape Value) whose purpose is to safeguard and enhance the character and quality of landscapes, promote understanding and awareness of the distinctive character and special qualities of local landscapes, and safeguard and promote important settings for outdoor recreation and tourism locally.
<b>Local Transport Strategy (LTS)</b>
Sets out the council's vision for transport and the policies it wants to put into action.
<b>Main Issues Report (MIR)</b>
This sets out the main planning issues for the Development Plan area and then a series of options as to the planning policies that could be used in the Proposed Development Plan. One of these options is known as the Preferred Option. Members of the public and planning stakeholders are consulted on this Report so that the Planning Authority can gain their opinion.
<b>Masterplan</b>
Explains how a site or a series of sites will be developed, describing and illustrating the proposed urban form in three dimensions.
<b>Monitoring Statement</b>
Highlights the changing context for planning and examines how the adopted plan has performed to date.
<b>National Planning Framework 2 (NPF2)</b>
A strategy for Scotland's development to 2030, setting out strategic development priorities to support the Scottish Government's central purpose – sustainable economic growth. Planning authorities are required to take the Framework into account when preparing development plans and it is a material consideration in the determination of planning applications.
<b>National Planning Framework 3 (NPF3)</b>
A strategy for Scotland's development for the next 20 - 30 years, setting out strategic development priorities to support the Scottish Government's central purpose – sustainable economic growth. Planning authorities are required to take the Framework into account when preparing development plans and it is a material consideration in the determination of planning applications. NPF3 replaced NPF2 on 23 June 2014.

<b>Open Space</b>
Open areas or greenspace consisting of any vegetated land or structure, water or geological feature within or on the edges of a settlement. This can include parks and gardens, play areas, sports pitches, wildlife areas, allotments, trees, woodland, paths and 'civic space' such as squares, market places and other paved or hard landscaped areas with a civic function.
<b>Open Space Strategy</b>
Provides the evidence base and sets out how a local authority will invest in and manage the open space in its area. Applies to all the open space – not just that owned or managed by the authority – and cover parks, open space, town squares, streets, play space and housing land. The council's <i>Open Space Strategy</i> is published separately from the <i>Local Development Plan</i> .
<b>Out of Centre</b>
A location which is outwith and separate from a network centre. Differs from an Edge of Centre location.
<b>Placemaking</b>
The art of creating great places which are safe, vibrant, stimulating and welcoming, with a strong sense of identity, through successful planning and development.
<b>Planning Advice Notes (PANs)</b>
These are prepared by the Scottish Government and provide advice on good practice and other relevant information.
<b>Planning Obligation</b>
Section 75 of the Town and Country Planning (Scotland) Act 1997 (as amended by the 2006 Act) provides that a person may either by agreement with the Planning Authority or unilaterally enter into a planning obligation restricting or regulating the use of land in the district of the Planning Authority, either permanently or during such a period as may be prescribed by the agreement or obligation
<b>Pluvial flooding</b>
Also referred to as surface water flooding, it occurs when an extremely heavy downpour of rain saturates drainage systems and the excess water cannot be absorbed.
<b>Prime Agricultural Land</b>
Land falling into Classes 1, 2 and 3.1 in the Macauley Institute 'Land Capability for Agriculture' classification. It is generally recognised as being the most productive agricultural land.

<b>Registered Social Landlord (RSL)</b>	<b>Single Outcome Agreement (SOA)</b>
A not for profit housing association or housing cooperative that is registered with the Scottish Housing Regulator under the Housing (Scotland) Act 2001.	An agreement between the Scottish Government and each of Scotland's 32 local authorities, setting out strategic priority issues based on the Government's 15 "National Outcomes". West Lothian Community Planning Partners have agreed their vision for the West Lothian area and the strategic priorities that need to be addressed to achieve this vision which are expressed as outcomes to be delivered by the partners, both individually and jointly.
<b>Retail Impact Analysis (RIA)</b>	<b>Sites of Special Scientific Interest (SSSI)</b>
An assessment of the likely individual or cumulative impact of a proposed development on the vitality and viability of Network Centres	Key areas of marine or terrestrial conservation and wildlife importance. They are special for the nature conservation value of the plants, animals, habitats or rock formations that they contain. SSSI's are designated by Scottish Natural Heritage under the provisions of the Wildlife and Countryside Act 1981.
<b>Renewable energy</b>	<b>Spatial Strategy</b>
Those sources of energy which are naturally occurring within the environment and which can either be tapped without consuming the resource, or where the resource can renew itself on a human timescale. Examples of renewable sources of energy are wind, solar, hydro, wave, tidal, energy crops and plant waste.	The part of the <i>Local Development Plan</i> which sets out the scale and location of new development and infrastructure.
<b>Retail warehouse</b>	<b>Special Areas of Conservation (SAC)</b>
A large single-level store specialising in the sale of household goods such as carpets, furniture and electrical goods, and bulky DIY items, catering mainly for car-borne customers and often in out-of-centre locations. <b>Scheduled Monument</b>	<b>Strategic Development Plan (SDP)</b>
A nationally important archaeological monument protected by the Ancient Monuments and Archaeological Areas Act 1979. It is a criminal offence to alter or physically impact on a Scheduled Monument without prior Scheduled Monument Consent.	Introduced by the Scottish Government in 2008 as replacement for Structure Plans, these plans set out a clear vision and spatial strategy for an area. Largely the plans focus on key land use and development issues that cross planning authority boundaries.
<b>SESplan</b>	<b>Strategic Environmental Assessment (SEA)</b>
The organisation that operates on behalf of City of Edinburgh, East Lothian, Midlothian, West Lothian, Borders and Fife Councils. The key role of SESplan is to prepare and maintain an up to date Strategic Development Plan for the area.	Aims to provide a systematic method of considering the effects on the environment of a plan or programme with the aim of helping to reduce or avoid environmental impacts. All development plans must meet the requirements for SEA.
<b>Sequential approach</b>	
The sequential approach requires that locations for all retail and commercial leisure developments be considered in the following order: Town and Local Centres/Edge of Centre/ Commercial Centre/Out of Centre locations that are, or can be made, easily accessible by a choice of transport modes	

<b>Sustainable Drainage Systems (SUDS)</b>
A method of water management on development sites designed to mimic natural systems, by creating alternatives to rapid run-off. Infiltration drains, ponds, etc attenuate flood flows, allow for pollutants to settle out, and also provide opportunities for habitat creation. More sustainable than the traditional practice of routing run-off through a pipe to treatment works or a watercourse
<b>Supplementary Guidance (SG)</b>
Provides further information or detail in respect of policies or proposals set out in the <i>Strategic Development Plan</i> or <i>Local Development Plan</i> . Statutory guidance adopted in connection with a plan, forms part of the development plan. Planning authorities may also publish other non-statutory guidance that does not form part of the development plan.
<b>Sustainable development</b>
The <i>Bruntland Report</i> (World Commission on Environment and Development, "Our Common Future") emphasised the need for an approach based on sustainability i.e. "all our needs should be met in a way which does not compromise the ability of future generations to meet their own needs"
<b>Sustainable economic growth</b>
Building a dynamic and growing economy, whilst at the same time safeguarding our environment for future generations and ensuring our communities enjoy a better quality of life.
<b>Tax Increment Financing (TIF)</b>
An innovative mechanism for funding necessary public sector infrastructure investment. It uses the anticipated increase in business rates income expected as a result of the infrastructure project, to borrow the necessary funding.
<b>Town Centre</b>
The term town centre is used to cover town and district centres, irrespective of size, that provide a diverse and sustainable mix of activities and land uses which can create an identity that signals their function and wider role.
<b>Transport Assessment (TA)</b>
A form of appraisal and forecasting of the various impacts of the vehicular traffic likely to be generated by a new development, with proposals to mitigate these effects, and to encourage walking, cycling and the use of public transport as alternatives.

<b>Tree Preservation Order (TPO)</b>
An order promoted by the local authority preventing the felling, lopping, topping etc of specified trees or areas of woodland without specific consent. The order is made under Section 160 of the Town and Country Planning (Scotland) Act 1997.
<b>Vacant land</b>
Land within settlements that is unused or unsightly and which would benefit from development or improvement.
<b>Vitality and viability of town centres</b>
Vitality is a reflection of how busy a centre is at different times and in different parts. Viability is a measure of its capacity to attract ongoing investment, for maintenance, improvement and adaption to changing needs.
<b>Waste/ Waste Management</b>
Includes any substance that constitutes a scrap material or an effluent or other unwanted surplus substance arising from the application of any process; and any substance or article that requires to be disposed of as being broken, worn out, contaminated or otherwise spoiled (but does not include explosives).
<b>Water Framework Directive</b>
The Water Framework Directive, which came into force in 2000 establishes a new legal framework for the protection, improvement and sustainable use of all water bodies in the environment across Europe.
<b>West Lothian Local Plan (WLLP)</b>
The adopted local plan for the West Lothian area (2009).
<b>Windfall sites</b>
Non-allocated sites that come forward for development and contribute to the land supply
<b>Zero Waste Plan</b>
Scottish Government's vision for a zero waste society. This vision describes a Scotland where all waste is seen as a resource. Waste is minimised; valuable resources are not disposed of in landfills, and most waste is sorted, leaving only limited amounts to be treated.
