# **Privacy Notice**

### Community Regeneration - Gala and Similar Annual Events Grant Funding

In accordance with the Data Protection Law the following information serves as a 'Privacy Notice' for the information gathered, collected, processed and stored for the administration of the Gala and Other Similar Annual Events Grant Fund administered by Community Regeneration.

#### What Information do we need?

- Copies of certificates of insurances if requested

# How will we use information we hold about you?

Your data will be used to:

- Assess your application, progress your application, payment of & financial monitoring of the grant.
- Contact you regarding the Gala Fund in future years
- To contact you regarding information that may be relevant to your organisation including relevant events.
- To contact you for feedback regarding the quality of services provided to you.

### Who will we share your information with?

We will share your information with internal West Lothian Council colleagues in services such as; Central Administration, Events Coordinator, Financial Management Unit, Insurance, Licencing, Operational Services as required to carry out your request.

If you are a gala committee we may share your contact details with Zurich Insurance who will contact you in connection with provision of your Public Liability Insurance which is provided/paid for by West Lothian Council.

## How long do we keep your records?

We will endeavour to keep your information accurate and up-to-date, and to update or remove the data upon request by you. The council will only keep your information for a maximum of seven years unless there is a requirement to keep your information longer. After this time personal information will be securely destroyed.

Unsuccessful applications will be retained until the end of the financial year and after this time personal information will be destroyed.
